#### 2019-2020 Budget Assumptions

#### Revenue

- State support at \$590 Million, \$3.644 million
- Tuition, 2% increase to \$105 per credit
- Timber revenue at \$450,000
- Beginning fund balance at \$1.1 million

#### **Expenditure**

- PERS rate at 22%
- Steps
- Insurance cap
- Annual renewals (+/-)
- Utilities
