



## Citizenship Documentation

The U.S. Department of Education could not confirm that you are an U.S. citizen or national or an eligible non-citizen. Federal regulations require verification of your status before CCC can offer you student financial aid. Please review the categories below to find the one that applies to you. **Bring this form and original document to the Financial Aid Office.**

Please check the citizenship status that applies to you and attach one of the required documentations:

- U.S. Citizen or Naturalized U.S. Citizen
  - Birth Certificate if you were born in the U.S. -or-
  - Certification of Naturalization (N-550 or N-570) -or-
  - Certificate of Citizenship (N560 or N561) -or-
  - State Department Form (FS-240, 545, DS 1350) -or-
  - U.S. Passport (current or expired)
  
- Permanent Resident of the U.S.
  - Resident Alien Card (I-551 issued before 1997) copy of both sides required -or-
  - Permanent Resident Card (I-551 issued after 1997) copy of both sides required -or-
  - Alien Registration Receipt Card (I-151 issued before June 1978) -or-
  - Arrival/Departure Record (form I-94) stamped "Processed for I-551" or "Temporary Form I-551"
  
- Eligible Non-citizen
  - Arrival/Departure Record (form I-94) stamped or endorsed as one of the following:
    - \* "Admitted as a Refugee Pursuant to Section 207 of the Act. If you depart the U.S. you will need prior permission to return. Employment Authorized" -or-
    - "Status changed to refugee pursuant to Section 207 (c) (2) of the Immigration nationally Act, on \_\_\_\_\_ . Employment Authorized."
    - \* "Asylum status granted pursuant to Section 208, USCIS. Valid to \_\_\_\_\_ . Employment Authorized."
    - \* A stamp indicating that the student has been paroled into the United States for at least one year, with a date that has not expired.
    - \* "Cuban-Haitian Entrant"

Note: Documentation provided as proof of your immigration status may legally be photocopied by the Financial Aid Office as long as the photocopy is made for this lawful purpose. Document photocopying is generally not permitted for other purposes.
